On February 12, 2021, the New York State Education Department (NVSED Department") submitted a waiver request to the United States Department of Education (USDE) on behalf of all Local Education Agencies (LEAs) in New York State seeking flexibilitym federal accountability requirements the 202021 schoolyear<sup>1</sup>

Specifically, the waiver request addressed the unique circumstances caused by the ongoing pandemic. The Department argued that even in cases where databeoctddected for the individual accountability indicators order to make determinations at the elementary/middle and high school levels, there is much concern that such determinations for the 12020 ool year will be distorted by the disparities ass the State in learning modality and device/internet connectivity access. These disparities undermine the Department's ability to make accurate judgements about individual indicators and overall school and district performance, effectively negating the ability to meaningfully differentiate among schapotd or offer appropriate supports.

This memo is to inform you that USDE granted SED a waiver of the following requirements of the Elementary and Secondary Education Act (ESEA), as recently amended by eary Student Succeeds Act (ESSA)

x Accountability and school identification requirements inectSons 1111(c)(4) and 1111(d)(2)(C)(D): the requirements that a State measure progress towarghTerm Goals and Measures of Interim Progress(MIP); meaningully differentiate, on an annual basis, all public schools, including adjusting the Academic Achievement indicator based on a participation rate below 95 percent; and identify schoolschorpCehensiveTargeted, and additional TargetedSupport and Inprovement based on data from the 2020school year.

## ESSA Accountability Implications

Based on the waiver granted by USDE, NYSED will present propassed ndments to Commissioner's Regulations related accountability and schools in Receivership to Board of Regentsat its September 2021 meeting. Proposed amendments will be consistent with the following actions:

- x NYSED will waive all requirements pertaining to participation rate in state assessments administered during the 2020- schoolyear.
- x NYSED will not make 202122 school year accountability statours level determinations based on 202021 school year data for any of the indicators used in New York's accountability system composite performance; academic progress; student growth; English Language Proficiency; chronic absenteeism; graduation rate; and college, career, and civicreadiness.
- x NYSED will freeze the accountability status of all schools and distr**Adis**districts and schools will have the same accountability status in the **2026** hool year that the districts and schools had in the 20**20**-school year. Therefore:
  - Any district that was identified as a Target District in the 2020 school year will maintain that identification status in the 2022 school year.
